
Please be informed that today, Ayala Land, Inc. (ALI) entered into a Sale and Purchase Agreement with Global Technologies International Limited (GTIL) to acquire the latter's 32% stake in ALI Property Partners Co. (APPCo) for P3.52 billion.

APPCo owns BPO buildings in Makati, Quezon City and Laguna, with a total gross leasable area of approximately 230 thousand square meters.

This acquisition is aligned with ALI's thrust of expanding its office leasing business and increasing its recurring income.
