Dear Atty. Malabanan,

This has reference to PSE's letter, dated January 2, 2008, requesting Ayala Land to confirm/deny the veracity of the information contained in the news article published in The Philippine Star entitled "ALI-KHI hotel proj to get tax perks."

Please be advised that the said article is generally correct, subject, however, to the following clarifications:

- KHI-Manila Properties, Inc., a company which is 20% owned by Ayala Land, Inc., has indeed applied for a fiscal incentive package with the Board of Investments (BOI) under the government's medium Term Development Plan for tourism. However, we have not received any formal notification on the granting of such incentives from the BOI to date.
- The land was already turned over by ALI to KHI-ALI Manila, Inc. last December 2007. The Ansons Department Store and the transport terminals which previously occupied part of the land to be developed have already been relocated. Ansons currently occupies the first two floors of a new carpark building between Makati Shangri-La and Landmark. The jeepney terminal has moved to the first parking level of the Park Square 1 carpark beside Dusit Hotel while the FX/AUV terminal has moved to EDSA carpark.
