We write in response to your letter dated December 16, 2011 requesting Ayala Land, Inc. ("the Company") to clarify and/or confirm the news article entitled "Ayala firms up road foray" posted in *bworldonline.com* on December 16, 2011. The article reported, in part, that:

"Moreover, Ayala Land is eyeing a bid for the Laguindingan Airport O&M deal, Mr. Francia said."

The Company has expressed its interest to participate in various private-public partnership (PPP) infrastructure projects that the government has identified and will roll out, including the Laguindingan O&M project. However, we cannot confirm if the Company will eventually participate in the bid, as our decision will depend on many factors including our assessment of the attractiveness and potential value of the project. At this time, we can only wait for the government's proposed terms of the bid for this project.
