Please be advised that Ayala Land, Inc. (the "Company") signed today a 35-year lease agreement with Teodoro B. Pison, Josefina B. Pison-Ortiz, Roberto B. Pison and Riverside Boardwalk Properties, Inc. for the development of a two-hectare property located at Riverside Boardwalk, Barangay San Rafael, Mandurriao, Iloilo City. The entire project will consist of three (3) business process outsourcing (BPO) facilities with a total of 19,000 square meters of gross leasable area (GLA).

The initial phase will involve the construction of the first building with approximately 9,500 square meters of GLA and an estimated project cost of Php305 million. The start of construction is scheduled in the second quarter of this year and is expected to be completed by the first quarter of 2011.

Iloilo City is identified by the Business Processing Association of the Philippines (BPAP) as one of the Next Wave Cities (NWC) for BPO firms. It has an attractive power, telecommunications, commercial sea and airport infrastructure and offers one of the lowest rental, power and average base pay rates in the country.

Ayala Land's project will be the biggest BPO development in Iloilo to date and is consistent with the Company's goal of expanding into, developing and redeveloping strategic areas within attractive growth centers across the country in order to deliver on the expectations of its customers and shareholders.
