Please be informed that 223 grantees subscribed to a total of 14,170,576 common shares at Php30.29 per share today, May 19, 2022. Of the 14,170,576 common shares subscribed, 10,072,622 shares are immediately available for issuance while the remainder will become available upon approval by the Securities and Exchange Commission of the Corporation's application for exemption from the registration requirements. The option price is the average price of our common shares at the Philippine Stock Exchange over the last 30-day trading as of February 14, 2022, less 15% discount.

As a result of the subscriptions of the 223 stock option grantees, the number of our issued and outstanding common shares are now 15,391,268,583 and 14,805,667,401, respectively.
